AWARDS

The Robert Little Memorial Fire Safety Awards are presented to the top 3 Fire Companies or Departments, in three population categories, who in the opinion of the Awards Committee, have done the outstanding job of providing Fire Safety Education Programs to the citizens of their communities. First place receives \$800, second place receives \$600 and third place receives \$400 in each category.

The awards in the Division A category are open to all Fire Companies or Departments whose total population of all municipalities served first due is greater than 10,000 people, as determined by the latest census.

The awards in the Division B category are open to all Fire Companies or Departments whose total population of all municipalities served first due is between 5,000 and 9,999 people, as determined by the latest census.

The Awards in the Division C category are open to all Fire Companies or Departments whose total population of all municipalities served first due are 4,999 or less people as determined by the latest census. The Robert Little Memorial Fire Safety Education Awards are sponsored by VFIS.

Up to thirty Fire Companies or Departments that submit eligible entries will receive a \$200 grant from the Firemen's Association State of Pennsylvania Fire Safety Education Committee including the 9 division winners.
